This Certificate of Registration has been issued under the *Export Control Act 1982*. The registration of an establishment is continuous and remains in force unless the occupier requests that the establishment to be deregistered, or the Secretary revokes the registration of the establishment in accordance with export legislation.

The occupier of the establishment has the responsibility, on an 'Application for Registration or Notification to the Secretary of Change of Details of an Establishment' form (known as an EX26 form), or by letter to notify the Secretary within 7 days if any of the following events or circumstances occurs:

- if you cease to be the occupier (may be an individual person, a company, or a partnership) of the establishment
- if there is a change to your occupier mailing address
- if there is a change of occupier name
- if the registration is transferring to another entity (eg following a sale)
- if there are additions of persons in management and control
- if there are amendments to details of persons in management and control
- if you are adding or amending an authorised signatory or EXDOC RFP Validator or Agent
- if you are an **INDIVIDUAL PERSON**, you must tell us
 - if you're convicted of a relevant offence**,
 - if you become bankrupt, or execute a deed or arrangement or assignment under the *Bankruptcy Act 1966*
- if you are a **COMPANY** (a corporate body), the company must tell us
 - if the company itself, or a person who manages or controls the operations at the establishment, is convicted of a relevant offence**,
 - if a court orders that the company be wound up,
 - if a resolution is passed that that the company be wound up voluntarily, or
 - if the company enters into administration under the *Corporations Act 2001* the administrator must be listed in management and control of the establishment and an EX26 should be completed.

- if you are a PARTNERSHIP, you must tell us
 - if the partnership itself, or a member of the partnership, is convicted of a relevant offence**, or
 - the partnership is dissolved.

Please Note: notification of the following will be accepted on company or business letterhead.

Bankruptcy, administrations, windup of company, dissolution of partnership, convictions for a relevant offence**, deregistration, cessation of occupancy, change of registered or overseas operations.

*** A relevant offence means an offence against a Commonwealth, State or Territory law for which the maximum penalty is a period of imprisonment or a fine of \$1000 or more.*


